Dear Governor Cuomo,

New York Housing Conference, a statewide affordable housing policy and advocacy organization, together with 121 organizations call on you to take immediate steps to implement a statewide affordable housing plan. As you know, \$2 billion in enacted funds for affordable and supportive housing cannot be spent without agreeing on a statewide housing plan in a signed memorandum of understanding with leaders of the Legislature.

Our state is in the midst of an affordable housing and homeless crisis and in desperate need of affordable and supportive housing. \$1 in NY State subsidy will leverage \$3 of bonds, tax credit equity and other permanent financing on a new construction projects across the state. This money should be financing affordable housing, creating jobs and spurring local economies across the state right now.

There is no time to waste...

- 1.5 million rent burdened households statewide
- 88,250 homeless statewide
- 392,039 families on NYC public housing & rental assistance waiting lists
- 200,000 households on NYC senior housing waiting lists an average of 7 years according to LiveOn NY

We ask that you waste no additional time in unlocking \$2B in enacted funds for affordable housing and come to agreement with Speaker Heastie and Senate Leader Flanagan by June 16th when session ends.
